A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3839 TO THE SAN DIEGO BLACK HEALTH ASSOCIATES FOR THE 1<sup>ST</sup> ANNUAL HIP HOP & WELLNESS EVENT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Black Health Associates requested funding for traffic management for the 1st Annual Hip Hop & Wellness 5k event; and

WHEREAS, the requested funding will be used to pay the costs for traffic management, which are payable directly to the City on behalf of the San Diego Black Health Associates for the San Diego Police Department's services; and

WHEREAS, the San Diego Black Health Associates' request for funding for the 1<sup>st</sup> Annual Hip Hop and Wellness 5k event benefits the community by promoting health and improving community relations; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$3839 to the San Diego Black Health Associates for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 2(d), which provides: "Enter into an Agreement with the City that specifies the responsibilities of the organization with respect to the use of funds awarded, and stipulating that all expenses shall be documented pursuant to the Agreement."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 4(a), which provides: "Funds will only be provided on a reimbursement basis. Funds will not be reimbursed without the documentation required under the agreement."

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations in the amount of \$3839 from the Community Projects, Programs, and Services Budget Fund No. 100000, Cost Center 1104110004, GL No. 512059, Council District 4, to the San Diego Police Department Fund No. 100000, Cost Center No. 1914131215 GL No. 500121, for traffic management for the 1st Annual Hip Hop and Wellness 5k Event sponsored by the San Diego Black Health Associates.
