A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,100 TO THE SCRIPPS RANCH CIVIC ASSOCIATION FOR THE SCRIPPS RANCH HIGH SCHOOL STREET RENAMING, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Scripps Ranch Civic Association has requested funding as the sponsor for the Scripps Ranch High School Street Renaming Project; and

WHEREAS, the Scripps Ranch Civic Association and Scripps Ranch High School are seeking to change the name of Treena Street south of Scripps Lake Drive to One Falcon Way, in honor of Scripps Ranch High School Falcons; and

WHEREAS Scripps Ranch High School has applied to the Development Services Department pursuant to the process established by Chapter 12, Article 5, Division 11 of the San Diego Municipal Code, titled Naming or Renaming of Public Streets and Other Rights-of-Way; and

WHEREAS, the funding requested by the Scripps Ranch Civic Association will be used to cover the fees associated with Scripps Ranch High School's application for street renaming in front of the high school, which are payable directly to the City; and

WHEREAS, City Council's authorization of this payment on behalf of the Scripps Ranch Civic Association does not constitute approval of the Scripps Ranch High School's application or a waiver of any requirements or approvals necessary for street re-naming as provided by Chapter 12, Article 5, Division 11 of the San Diego Municipal Code sections 125.1101, 125.1105, 125.1110, 125.1115, and 125.1120 and Chapter 12, Article 2, Division 1 of the San Diego Municipal Code section 112.0102; and

WHEREAS, the Scripps Ranch Civic Association's request for funding for the Scripps Ranch High School Street Renaming will benefit the community by honoring and promoting Scripps Ranch High School, one of the highest-rated schools in the San Diego Unified School District; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$3,100 to the Scripps Ranch Civic Association for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 2(d), which provides: "Enter into an Agreement with the City that specifies the responsibilities of the organization with respect to the use of funds awarded, and stipulating that all expenses shall be documented pursuant to the Agreement."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."


BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 4(a), which provides: "Funds will only be provided on a reimbursement basis. Funds will not be reimbursed without the documentation required under the agreement."

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer \$3,055 from the Community Projects, Programs, and Services Budget Fund No. 100000, Cost Center 1105110005, GL No. 512059, Council District 5, to Development Services Department:

- a). Fund No. 700036, Cost Center No. 1611120011, in the amount of \$270.00;
- b). Fund No. 200459, Cost Center No. 1611170012, in the amount of \$2,500.00;
- c). Fund No. 700036, Cost Center No. 1611000013, in the amount of \$285.00

to cover the permit costs for the street name change for Scripps Ranch High School to One Falcon Way, initiated by Scripps Ranch Civic Association.


