RESOLUTION NUMBER R- 310516

DATE OF FINAL PASSAGE JUN 22 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE AND ESTABLISH A TOW-AWAY ZONE ON FRIDAY AND SATURDAY BETWEEN 8PM AND 3AM ON 5TH AVENUE BETWEEN HARBOR DRIVE AND BROADWAY.

WHEREAS, San Diego Municipal Code section 86.0107 authorizes the City Council to establish tow-away parking zones; and

WHEREAS, the “No Park 5th/Active Loading Zone” Pilot Project seeks to remove parked vehicles along 5th Avenue between Broadway and Harbor Drive on Friday and Saturday nights to ease the flow of pedestrian traffic and improve public safety; and


WHEREAS, in order for the Project to be successful, City staff has determined that parking along that section of 5th Avenue should be converted to a tow-away zone during the hours of 8 p.m. to 3 a.m.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to establish a tow-away zone on Friday and Saturday between the hours of 8:00 p.m. and 3:00 a.m. on both sides of 5th Avenue between Harbor Drive and Broadway.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,800 from the General Fund, Fund 100000, 211611 Transportation and Storm Water Department Street Division operating budget for the installation of a tow-away zone including signs and related markings along both sides of 5th Avenue between Harbor Drive and Broadway, contingent upon the City Comptroller first certifying that the funds are, or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that this resolution will take effect on the date that Ordinance O-2016-87 becomes effective.


