WHEREAS, the current Encanto Neighborhoods Community Plan (Community Plan) was adopted on November 16, 2015; and

WHEREAS, City staff determined that several corrections to the Community Plan are needed and require City Council action, including zoning and land use map corrections; and


WHEREAS, as part of the Community Plan amendment, the 2008 General Plan will be amended because the Community Plan is a component of the General Plan; and
