A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE AMENDMENTS TO PARK AND RECREATION DEPARTMENT FISCAL YEAR 2016 CAPITAL IMPROVEMENT PROGRAM BUDGET ARE STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO SECTION 15262 OF THE STATE CEQA GUIDELINES.

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the City of San Diego has considered the potential environmental effects of the amendments to the Park and Recreation Department Fiscal Year 2016 Capital Improvements Program Budget; and

WHEREAS, the City of San Diego previously determined that the projects at Hickman Field Athletic Area Improvements and the North Park Mini Park are exempt from CEQA; and

WHEREAS, the City Council of the City of San Diego held a duly noticed public meeting and considered the written record for the amendments to the Park and Recreation Department Fiscal Year 2016 Capital Improvements Program Budget, as well as public comment; and

WHEREAS, the City Council, using its independent judgment, has determined that the amendments to the Park and Recreation Department Fiscal Year 2016 Capital Improvements Program Budget will not have a significant effect on the environment because the statutory exemption can be used for projects or actions involving only feasibility or planning studies for possible future actions which the agency, board or commission has not approved, adopted or funded and does not require preparation of an EIR, but does require consideration of environmental factors; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Amendments to Park and Recreation Department Fiscal Year 2016 Capital Improvements Program Budget (with the exception of amendments to the Capital Improvement Program Budgets for Hickman Field Athletic Area Improvements and the North Park Mini Park) are statutorily exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15262 as it is for planning and feasibility studies for possible future actions that have not been approved, adopted or funded does not require preparation of an environmental document but requires consideration of environmental factors. Project approvals will occur after environmental review is completed in accordance with CEQA Section 15004.
