DATE OF FINAL PASSAGE JUL 06 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO ACCEPT THE STATUS REPORT OF THE
UTILITY UNDERGROUNDING PROGRAM AND TO
APPROVE NEW UNDERGROUNDING PROJECTS.

WHEREAS, since 1970, overhead utilities in San Diego have been relocated underground in accordance with the California Public Utility Commission (CPUC) Rule 20A; and

WHEREAS, in 2003, the City established a Surcharge component which allowed undergrounding to occur in neighborhoods which would not qualify under Rule 20A; and


WHEREAS, in accordance with Council Policy 600-08, City staff provides an annual update on the status of all allocated underground conversion projects, as well as the status of expenditures and the underground conversion account; and

WHEREAS, Council Policy 600-08 provides that the City Council will approve an annual list of proposed Surcharge Projects and CPUC Rule 20A Projects, so that City staff can begin preparing materials for establishing corresponding underground utility districts at a future public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the report provided by City staff in accordance with Council Policy 600-08 (D)(3) on the status of projects, expenditures, finances for the City's Utility Undergrounding Program (UUP), and the status of the implementation of the Utilities Undergrounding Advisory Committee's recommendations is accepted.

BE IT FURTHER RESOLVED, that the allocation of projects to be funded using the Underground Surcharge Fund is approved.
