A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN DIANE VRANJES AND THE CITY OF SAN DIEGO.

WHEREAS, on January 20, 2015, Diane Vranjes filed suit against the City of San Diego alleging personal injuries arising from a trip and fall on a public sidewalk/street on January 17, 2014. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Diane Vranjes* v. City of San Diego, Case No. 37-2015-00002038-CU-PA-CTL.

WHEREAS, in Closed Session on May 24, 2016, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8; Nays, None; and absent, District 9, approved the Settlement.

WHEREAS, the City Council in closed session on May 24, 2016, authorized settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. Authorizing the Mayor or his designee to pay the sum of \$185,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of *Diane Vranjes v. City of San Diego*, Case No. 37-2015-00002038-CU-PA-CTL.
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$185,000 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing

one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue a check in the amount of \$185,000, made payable to Grimm, Vranjes and Geer Client Trust Account.
