- 1. - 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000,000, over five (5) years for the purpose of funding the As-Needed Architectural Services agreement with Roesling Nakamura Terada Architects, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Fund 200218, Underground Surcharge CIP, WBS No. A-ID.00001, Utilities Undergrounding Program, for the purpose of executing this agreement, and meeting the minimum contract requirements.
- 4. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
