WHEREAS, in Closed Session on May 24, 2016, the City Council, by the following votes:

WHEREAS, the City Council in Closed Session on February 9, 2016, authorized settlement of the Litigation for an amount consistent with the amount set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$375,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Garrett Slavin and Pamela Slavin, San Diego Superior Court Case No. 37-2014-000028796-CU-PO-CTL.

The Chief Financial Officer to appropriate and expend \$375,000 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. The Comptroller to issue a check in the amount of \$375,000, made payable to Simpson Law Group CTA ITF Garrett and Pamela Slavin.


