A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN CONNI CAMPBELL AND THE CITY OF SAN
DIEGO

WHEREAS, on May 3, 2013, CONNI CAMPBELL filed suit against the City of San Diego alleging personal injuries arising from the incident on arrest of plaintiff on September 2, 2012. Plaintiff brought suit in the Unites States District Court. The suit is entitled *Conni Campbell v. City of San Diego.*, United States District Court Case No. 14cv2359 GPC (RBB); and

WHEREAS, in Closed Session on June 21, 2016, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8; Nays, None; and absent, District 9, approved the Settlement.

WHEREAS, the City Council in closed session on June 21, 2016, authorized settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. Authorizing the Mayor or his designee to pay the sum of \$69,975.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Conni Campbell v. City of San Diego, et

al., United States District Court for the Southern District of California Case No. 14cv2359 GPC (RBB).

2. Authorizing the Chief Financial Officer to appropriate and expend \$69,975.00 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue one check, in the amount of \$69,975.00, made payable to James S. Iagmin, APC Client Trust Account and Conni Campbell.





