A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING COMPLETION OF A BASIN BOUNDARY MODIFICATION FOR THE SAN DIEGO FORMATION GROUNDWATER BASIN WITH THE CALIFORNIA DEPARTMENT OF WATER RESOURCES.

WHEREAS, the Public Utilities Department requests that City Council adopt a resolution in accordance with the California Department of Water Resources (DWR) requirement for the newly adopted Sustainable Groundwater Management Act (SGMA) to formally initiate a basin boundary modification request for the San Diego Formation basin; and

WHEREAS, in an effort to promote sustainable groundwater use in the State of California, the Sustainable Groundwater Management Act (SGMA) became law in September, 2014 and requires water agencies to form Groundwater Sustainability Agencies (GSA), which in turn adopt Groundwater Sustainability Plans (GSP) for long-term sustainable management and protection of the groundwater resource; and

WHEREAS, an initial step for the implementation of SGMA is to establish a groundwater basin boundary by completing a basin boundary modification application with the DWR; and

WHEREAS, the application for the modification has been submitted, reviewed and accepted by DWR, proper public noticing has been followed as required by DWR, and to complete the basin boundary modification application, a resolution proposing modification to consolidate three basins into one, and expand the boundaries to include the entirety of the

underlying San Diego Formation, which can then be managed as a single basin; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor is authorized to sign a resolution to complete a Basin Boundary Modification for the San Diego Formation Groundwater Basin with the California Department of Water Resources.
