DATE OF FINAL PASSAGE AUG 10 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AGREEMENT WITH SCHMIDT DESIGN GROUP FOR AS-NEEDED LANDSCAPE ARCHITECTURAL DESIGN SERVICES; AND RELATED EXPENDITURES.

WHEREAS, on October 23, 2014, the City of San Diego (City) and Schmidt Design Group entered into an agreement for as-needed landscape architectural design services to provide various support services for Capital Improvement Program (CIP) projects in an amount not to exceed \$1,000,000 (Agreement); and

WHEREAS, Schmidt Design Group has been working on the Park de la Cruz Neighborhood Park project and additional funds are needed to complete that task under their agreement; and

WHEREAS, this First Amendment to the Agreement will increase the capacity of the Agreement by adding \$500,000 to ensure timely completion of the Park de la Cruz Neighborhood Park project task and avoid the need for duplication of work by another consultant under a separate contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the Agreement with Schmidt Design Group to increase the amount of compensation from \$1,000,000 to \$1,500,000, for as-needed landscape architectural design services, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the First Amendment to the Agreement, on file in the Office of the City Clerk as Document No. RR - 310649 .

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,500,000, over five years for the purpose of funding the As-Needed Landscape Architectural Design Services Agreement and First Amendment with Schmidt Design Group, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
