A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING COUNCIL POLICY 700-22  
ENTITLED "TICKET POLICY FOR QUALCOMM STADIUM,  
PETCO PARK AND OTHER TICKETS PROVIDED TO THE  
CITY FOR ENTERTAINMENT PURPOSES."

WHEREAS, Council Policy 700-22 sets forth the guidelines for the distribution of tickets the City receives for Qualcomm Stadium, Petco Park, and other City events for entertainment purposes; and

WHEREAS, on March 23, 2016, the City Council Rules Committee recommended that changes be made to Council Policy 700-22 to increase utilization of tickets by non-profit and community-based organizations and to reward City employees for meritorious service, and make the policy more accessible and transparent; and

WHEREAS, the proposed amendments to Council Policy 700-22 include:

1. Giving behest authority for the Council to the Council President;
2. Making Council Administration the Ticket Coordinator for the Council;
3. Specifying that "qualifying charitable organizations" include unincorporated community organizations, such as Friends of the Library and similar groups, and local chapters of organizations;
4. Prioritizing ticket requests for qualifying charitable organizations;
5. Prioritizing ticket requests for meritorious City employees through the Employee Rewards and Recognition program;

6. Limiting recipients of tickets to one event every six months for qualifying charitable organizations;

7. Mandating that ticket recipients sign a code of conduct form; and


WHEREAS, the City Council has reviewed the proposed amendments to Council Policy 700-22 presented at this meeting; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego as follows:

1. The Council hereby approves the amendments to Council Policy 700-22 titled "Ticket Policy for Qualcomm Stadium, Petco Park and Other Tickets Provided to the City for Entertainment Purposes" as set forth and on file in the office of the City Clerk as Document No. RR- 310657.

2. The City Clerk is instructed to update the Council Policy Manual to include the amended Council Policy 700-22.


