A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING AN AS-NEEDED AGREEMENT  
WITH GEOSYNTEC CONSULTANTS, INC. FOR LANDFILL  
ENGINEERING SERVICES.

WHEREAS, the Environmental Services Department requires the as-needed landfill engineering services of an environmental consultant firm for the City of San Diego's (City) landfills, in order to maintain compliance with applicable regulatory requirements; and

WHEREAS, in conformance with Council Policy 300-07 and Administrative Regulation 25.60, the City advertised a Request for Proposals for as-needed landfill engineering services related to the City's landfills (the Services); and

WHEREAS, Geosyntec Consultants, Inc. was selected as the most highly qualified firm to provide the Services, subject to Council approval; and

WHEREAS, the Environment Committee heard this item on July 21, 2016, and recommended that the City Council approve the contract award to Geosyntec Consultants, Inc.;

NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with Geosyntec Consultants, Inc. for as-needed landfill engineering services, for a period of five years, in an amount not to exceed \$1,000,000, under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR- 310674.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000,000 from Refuse Disposal Fund No. 700039, solely and exclusively to provide funds for the Agreement, contingent upon Council approval of the annual Appropriations Ordinance for the applicable fiscal year and upon the Chief Financial Officer first furnishing one or more certificates demonstrating funds are, or will be, on deposit with the City Treasurer.

3. That the Chief Financial Officer is authorized to appropriate and expend \$1,000 from Refuse Disposal Fund No. 700039, for the purpose of executing the Agreement and meeting minimum contract requirements.


