DATE OF FINAL PASSAGE SEP 26 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE THE CONVERSION OF HYATT
STREET AND EAST HYATT STREET TO ONE-WAY
OPERATION.

WHEREAS, residents of Hyatt Street have expressed concern about the traffic flow along
the portion of Hyatt Street that is south of East Hyatt Street and all of East Hyatt Street; and

WHEREAS, a petition to convert the streets to one-way operation was signed with 75%
of residents in favor; and


WHEREAS, the Linda Vista Planning Group voted 5-0-3 in support of the requested
change; and

WHEREAS, converting the streets to one-way operations will provide a more orderly
flow of traffic and reduce congestion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his
designee is authorized to convert the portion of Hyatt Street that is south of East Hyatt Street and
all of East Hyatt Street to a one-way street.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds not to exceed \$3,400 from fund 100000 General Fund, Transportation & Storm Water Department – Street Division’s (211611) operating budget, for the installation of the necessary signs and markings to convert Hyatt Street and East Hyatt Street to a one-way street.




