BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to convert the portion of Hyatt Street that is south of East Hyatt Street and all of East Hyatt Street to a one-way street.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds not to exceed \$3,400 from fund 100000 General Fund, Transportation & Storm Water

Department – Street Division's (211611) operating budget, for the installation of the necessary signs and markings to convert Hyatt Street and East Hyatt Street to a one-way street.
