WHEREAS, in Closed Session on July 19, 2016, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 8, and 9; Nays, None; and All Present, approved the Settlement.

WHEREAS, the City Council in Closed Session on July 17, 2016, authorized settlement of the Litigation for an amount consistent with the amounts set forth; NOW THEREFORE,

BE IT RESOLVED, by Council of the City of San Diego, that the council authorizes.

- 1. The sum on \$1,000,000 to be paid from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation
- 2. The Chief Financial Officer to appropriate and expend \$1,000,000 from the Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
