A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY 100-21
ENTITLED "FUNDING FOR MAINTENANCE ASSESSMENT
DISTRICT FORMATION."

WHEREAS, Council Policy 100-21 sets forth the policy and processes for formation, budgeting, and management practices for the City's Maintenance Assessment Districts (MADs); and

WHEREAS, the Municipal Code was recently amended and updated and amendments to Council Policy 100-21 are now necessary to, amongst other things, establish consistency between the Council Policy and the Municipal Code; and

WHEREAS, the proposed amendments to Council Policy 100-21 include:

1. Outlining the process for formation of new MADs using City funds;
2. Clarifying the procedures, requirements, and timing for the petition process to ensure sufficient and current property owner support for MAD formation;
3. Creating consistency with the Municipal Code regarding preparation of the Engineer's Report;
4. Establishing two sources of City funds for MAD formation; and
5. Setting forth standards for a nonprofit owner's association to administer MADs, including cost reimbursements, budgetary reserves, and capital advances.

WHEREAS, the City Council has reviewed the proposed amendments to Council Policy 100-21; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego as follows:
