A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN EDUARDO AND PATRICIA PEREZ AND THE CITY OF SAN DIEGO

WHEREAS, Eduardo and Patricia Perez filed a claim with the City of San Diego (City) for damages to their residence and property located at 6212 Cabaret Street, San Diego CA 92120, following the failure of a City storm drain on January 5, 2016. Claim No. 12282 was reviewed by City of San Diego's Risk Management Department; and

WHEREAS, on July 12, 2016, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 8, 9; Nays, None; and Absent, None, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. Authorizing the Mayor or his designee to pay the sum of \$98,743.08 from the Liability Fund 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the January 5, 2016 incident that is the subject of Eduardo and Patricia Perez's claim. The City has advanced \$50,000 to claimants;
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$48,743.08 from the Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
