The City has advanced \$42,960.82 to claimant;
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$156,312.95 from the Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

3. Authorizing the Comptroller to issue a check for the outstanding balance of One Hundred Fifty-Six Thousand, Three Hundred Twelve dollars and Ninety-Five cents (\$156,312.95) made payable to Rebecca Woolston.
