A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE THE WATER SUPPLY ASSESSMENT FOR THE 7TH & MARKET PROJECT TO FULFILL THE REQUIREMENTS OF CALIFORNIA STATE WATER CODE SECTION 10910.

WHEREAS, on January 1, 2002, Senate Bill 610 (SB 610) and Senate Bill 221 (SB 221) took effect, and are now part of the California State Water Code Section 10910, which requires the preparation of a water supply assessment (WSA) for inclusion in the California Environmental Quality Act (CEQA) documentation for projects that demand an amount of water equivalent or greater than the amount of water required by a 500 dwelling unit project; and


WHEREAS, a WSA assesses the water supply capability over a 20-year planning horizon to meet the projected demands of a project as well as the existing and other planned development projects within the City's service area in normal, dry, and multiple dry year forecasts; and

WHEREAS, Civic San Diego (CSD) requested that the Public Utilities Department (Department) prepare a WSA as part of the environmental review for the 7th & Market Project (Project), and the Department found that the Project meets the threshold requirements defined by Water Code § 10912(a)(7) and requires the completion of a WSA in conformance with SB 610; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Water Supply Assessment for 7th & Market Project is approved to fulfill the requirements of California State Water Code Section 10910.
