A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE AN INCREASE TO THE FISCAL YEAR 2017 CAPITAL IMPROVEMENTS PROGRAM FOR THE MARKET STREET FROM 47TH STREET TO EUCLID AVENUE COMPLETE STREET PROJECT.

WHEREAS, in February 2016 the City of San Diego received an Active Transportation

Program (ATP) grant that was awarded to the Jacobs Center for Neighborhood Innovation by the

Department of Transportation (Caltrans) for the purpose of providing pedestrian and bicycle

improvements along Market Street from 47th Street to Euclid Avenue; and

WHEREAS, the project will improve pedestrian and bike access along Market Street from 47th Street to Euclid Avenue and neighboring streets, and will improve safety for the Market Street multimodal transit center and nearby schools; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$4,016,000 if the grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to add CIP S-16061, Market Street, 47th Street to Euclid Avenue "Complete Street", to the Fiscal Year 2017 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Fiscal Year 2017 Capital Improvements Program Budget in CIP S-16061, Market Street, 47th Street to Euclid Avenue "Complete Street" and to appropriate and expend \$4,016,000 from State Fund, 600000, Federal award, Grant No. 1000458-2016, and \$700,000 from Fund 400000, Capital Outlay-Sales Tax, for the purpose of establishing a "Complete Street" project, contingent

upon the receipt of a fully executed grant agreement, the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer and contingent upon completing the environmental reviews to construct the project.
