A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO EXPEND \$6,610,000 TO ACQUIRE 13.599 GROSS ACRES OF REAL PROPERTY FROM PARDEE HOMES PURSUANT TO THE PACIFIC HIGHLANDS RANCH – SUBAREA III NCFUA COMMUNITY PARK SITE PURCHASE AGREEMENT.

WHEREAS, Pardee Homes, a California corporation, (Pardee) owns that certain 13-acre parcel of real property located within Subarea III in the North City Future Urbanizing Area in the City of San Diego, California with Assessor Parcel Number APN 305-040-33 (Property); and

WHEREAS, the City of San Diego and Pardee's predecessor, Pardee Construction

Company, entered into that certain Pacific Highlands Ranch – Subarea III NCFUA Community

Park Site Purchase Agreement, which was approved by the San Diego City Council on

September 8, 1998, by San Diego Ordinance O-18579 (Purchase Agreement). The Purchase

Agreement provided for the City's purchase of either a 13-acre site or a 20-acre site for a

community park; and

WHEREAS, the Purchase Agreement was amended by that certain First Amendment to Pacific Highlands Ranch – Subarea III NCFUA Community Park Site Purchase Agreement approved by City Council on February 18, 2003, by San Diego Ordinance O-19150 (First Amendment), which identified the Property as the 13-acre community park site; and

WHEREAS, the First Amendment established a formula for determining the purchase price of the community park site as the market value of the community park site as of September 26, 2001, plus costs incurred by Pardee since September 26, 2001, for the following: (i) real property taxes attributable to the community park site; (ii) maintenance costs; and (iii) interest costs on loans attributable to the community park site; and

WHEREAS, an independent MAI appraiser determined the market value of the Property as of September 26, 2001, to be \$5,060,000; and

WHEREAS, the City and Pardee have agreed that the costs attributable to the Property incurred by Pardee since September 26, 2001, total \$1,550,000. The agreed upon total purchase price of the Property is \$6,610,000; and

WHEREAS, pursuant to the Purchase Agreement, the grant deed will restrict use of the Property as a park site in perpetuity and provide for reversion of the Property to Pardee in the event that the Property is not used solely and perpetually for a park site; and

WHEREAS, the City and Pardee have entered into a Reimbursement Agreement, approved by the City Council on April 13, 2016, as Ordinance O-20633, for the design and construction of a community park and recreation building on the Property, which will be reimbursed from the Pacific Highlands Ranch Facilities Benefit Assessment funds pursuant to that Reimbursement Agreement; and

WHEREAS, the City desires to acquire the fee interest in the Property for a community park; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorized to expend an amount not to exceed \$6,610,000 from CIP RD-16002, PHR Community Park and Rec Bldg, Fund 400090, Pacific Highlands Ranch Facilities Benefit Assessment, for the purchase of 13.599 gross acres of real property from Pardee Homes, a California corporation, for a community park, contingent upon the Chief Financial Officer furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to execute and deliver all such agreements and all other instruments, including acceptance of the Grant Deed, to effect and complete the acquisition of the 13.599 gross acres of land from Pardee Homes.
