A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXPANSION OF THE
RESIDENTIAL PERMIT PARKING AREA "E" IN THE
CLAIREMONT MESA AREA.

WHEREAS, Residential Permit Parking Area "E" in the Clairemont Mesa area was established in 2003; and

WHEREAS, parking usage and occupancy studies performed in recent years and corroborated by field inspections performed by Traffic Engineering staff have determined that the subject area is adversely impacted by commuter parking; and

WHEREAS, a petition representing a majority of affected residences has provided support for an expansion of the Permit Parking Area "E"; and

WHEREAS, the proposed action would be the third modification of the district and would add a total of 84 new properties; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of San Diego Municipal Code section 86.2005(b), the existing Residential Permit Parking Area "E" shall be expanded to include the properties on Ashford Street, Ashford Place, Ashford Court, Baltic Street, Cullen Street, Argyle Street, Markham Street and Atlas Street as listed in Attachment 2.

BE IT FURTHER RESOLVED, that the Street Division of the Transportation & Storm Water Department shall install the necessary signs on the designated streets, and the regulations

hereinabove imposed shall become effective upon the installation of such signs.


