A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DENYING AN APPEAL AND UPHOLDING THE ENVIRONMENTAL DETERMINATION FOR THE 3503-3517 INDIANA STREET, PROJECT NO. 388089.

WHEREAS, an application was submitted to the City of San Diego for a tentative map with public right-of-way vacations and site development permit for the demolition of two existing single dwelling units, and the construction of seven detached single dwelling condominium units on a 0.517 acre site located at 3503-3517 Indiana Street project (Project), in the MR-1000 zone of the Mid-City Communities Planned District within the Greater North Park Community; and

WHEREAS, on May 31, 2016, the Environmental Analysis Section of Development

Services Department determined the Project to be exempt from the California Environmental

Quality Act (CEQA) pursuant to CEQA Guidelines Section 15332 (In-fill Development Projects)

and a Notice of Right to Appeal Environmental Determination was posted; and

WHEREAS, on June 14, 2016, Felix Tinkov, Esq. filed an Environmental Determination Appeal Application (Appeal); and

WHEREAS, the Appeal was heard before the City Council on October 18, 2016; and WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter required the City Council to act as a quasi-judicial body where a public hearing was required by law implicating due process rights of individuals affected by the

decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Appeal is hereby denied and the environmental determination is upheld.
