A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE THE WATER SUPPLY ASSESSMENT FOR THE BROADWAY BLOCK PROJECT TO FULFILL THE REQUIREMENTS OF CALIFORNIA WATER CODE SECTION 10910.

WHEREAS, On January 1, 2002, Senate Bill 610 (SB 610) and Senate Bill 221 (SB 221) took effect, and are now part of California Water Code Section 10910 which requires the preparation of a Water Supply Assessment (WSA) for inclusion in the environmental documentation of projects that would demand an amount of water equivalent or greater than the amount of water required by a 500 dwelling unit; and

WHEREAS, a WSA assesses the water supply capability over a 20-year planning horizon to meet the projected demands of a project as well as the existing and other planned development projects within the Public Utilities Department (Department)'s service area in normal, dry year, and multiple dry year forecasts; and

WHEREAS, Civic San Diego (CSD) requested that the City of San Diego (City)

Department prepare this WSA as part of the environmental review for the Broadway Block

Project (Project), and upon review, the Department found that the Project meets the threshold requirements defined by California Water Code Section 10912(a)(7) and requires the completion of a WSA in conformance with SB 610; and

WHEREAS, the Project occupies the City block bounded by 7th and 8th Streets and Broadway and C Street in downtown San Diego, and the existing land uses of the Project site are: office, retail, warehouse, restaurant, and residential spaces with two small parking lots; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Council approves the Water Supply Assessment for the Broadway
 Block Project to fulfill the requirements of California Water Code Section 10910.
