A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING THE PURE WATER SAN DIEGO PROGRAM.

WHEREAS, on May 15, 2014, the City Council of the City of San Diego passed a resolution supporting the Pure Water San Diego Program, and

WHEREAS, on August 5, 2015, the Public Utilities Department submitted an application to Development Services Department for the Pure Water San Diego Program (Project); and

WHEREAS, the Pure Water San Diego Program would use advanced water purification technology to produce potable water from recycled water and provide a safe, reliable and cost-effective drinking water supply for San Diego; and

WHEREAS, the Pure Water San Diego Program consists of design and construction of new advanced water purification facilities and a new reclamation plant; upgrades to existing water reclamation and wastewater treatment facilities; and design and construction of new pump stations and pipelines which may be subject to future environmental review during project level work; and

WHEREAS, the City, as lead agency under the California Environmental Quality Act (CEQA), has prepared and completed a Program Environmental Impact Report and a Mitigation Monitoring and Reporting Program covering the Pure Water San Diego Program; and

WHEREAS, the Council of the City of San Diego has reviewed and considered the final EIR No. 438188/SCH No. 2014111068 prior to approving the Project; NOW, THEREFORE,

BE IT RESOLVED, the Council of the City of San Diego adopts the Resolution to approve the Pure Water San Diego Program, as described and analyzed in the PEIR No. 438188/SCH No.2014111068.
