A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING SETTLEMENT OF TRENT VEASEY

WHEREAS, on December 10, 2014, Plaintiff Trent Veasey filed suit against the City of San Diego [City] alleging personal injuries arising from his interaction with former San Diego Police Officer Christopher Hays that occurred on December 17, 2013. The suit is entitled *Trent Veasey v. Christopher Hays, City of San Diego*, Case No. USDC 15cv1070 CAB (NLS); and

WHEREAS, in closed session on October 25, 2016, the City Council, by the following votes: YEAS, Districts 1, 2, 3, 4, 5, 6, and 7, NAYS, District 8, approved the settlement of Trent Veasey's claim for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. Authorizing the Mayor or his designee to pay the sum of \$160,000 from the Public Liability Fund 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Trent Veasey, United States District Court Case No. 15cv1070 CAB (NLS);
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$160,000 from the Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer;
