DATE OF FINAL PASSAGE DEC 01 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE THE CONVERSION OF
THORN STREET BETWEEN VAN DYKE AVENUE AND
43RD STREET TO A ONE-WAY STREET.

WHEREAS, community members including the City Heights Area Planning Committee have requested that the Transportation Engineering Operations (TEO) Division consider converting Thorn Street between Van Dyke Avenue and 43rd Street to one-way operation because of the narrow street width and the high number of pedestrians; and

WHEREAS, because there is no sidewalk on this portion of Thorn Street, pedestrians and vehicles have to share the roadway causing potential conflicts, particularly where the roadway curves and is at its narrowest point; and


WHEREAS, converting this street to a one-way operation will allow additional roadway width to be used by pedestrians and a temporary pedestrian pathway will be created along the south and east side of the roadway separating the pedestrians from the motorists; and

WHEREAS, the City Heights Area Planning Committee voted 12-0-0 in favor of converting this street to a one-way operation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to expend funds not to exceed \$2,200 from fund 100000 General Fund, Transportation & Storm Water Department – Street Division's (211611) operating budget, for

the installation of the necessary signs and markings to convert Thorn Street between Van Dyke Avenue and 43rd Street to a one-way street.


