DATE OF FINAL PASSAGE DEC 01 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ANGLE PARKING ON NEWTON AVENUE BETWEEN SOUTH 39TH STREET AND SOUTH 40TH STREET PROJECT; AND TAKING RELATED ACTIONS.

WHEREAS, the section of Newton Avenue between South 39th Street and South 40th Street is a 52-foot wide two-way street with parallel parking on both sides of the street; and

WHEREAS, converting the existing parking to angled parking on the north side of Newton Avenue would result in a gain of 17 parking spaces and no loss in the current number of three disabled parking spaces, which exceeds the required number of disabled spaces per the United States Access Board's Public Right-of-Way Accessibility Guidelines; NOW,

THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That in accordance with San Diego Municipal Code section 86.03 and California Vehicle Code section 22503, the installation of angle parking on the north side of Newton Avenue between South 39th Street and South 40th Street is authorized.

2. That the Chief Financial Officer is authorized to expend funds not to exceed \$4,000 from Fund 100000, General Fund, Transportation & Storm Water Department –

Street Division's (211611) operating budget, for the installation of angle parking on the north side of Newton Avenue between South 39th Street and South 40th Street.




