WHEREAS, under San Diego Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of meetings for the City Council, Standing Committees, and Budget Review Committee of the City Council, which includes meetings of the Housing Authority, for the period of January 1, 2017, through December 31, 2017, a copy of which is on file in the Office of the City Clerk as Document No. RR-310800-1, is hereby adopted.

BE IT FURTHER RESOLVED, that the Fiscal Year 2018 Budget Development and Fiscal Year 2017 Budget Monitoring Key Dates, as approved by the Budget and Government Efficiency Committee, a copy of which is on file in the Office of the City Clerk as Document No. RR- $310800^{-2}$ , is hereby adopted.
