WHEREAS, on December 5, 2016, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the General Plan and the University Community Plan; and

WHEREAS, on September 29, 2014, the City Council initiated an amendment to the University City Community Plan and directed the Planning Department to address the issues, and impacts relating to the right-of-way acquisition and construction improvements in Rose Canyon associated with the proposed Genesee Avenue Widening, and Regents Road projects (CIP Nos. S-00852 and S-00729); and

WHEREAS, since the adoption in July 1987, the University City Plan (UCP) development patterns, traffic conditions, and mobility priorities in the community are different from those previously anticipated and modeled; and

WHEREAS, the Genesee Avenue Widening and Regents Road projects have been on hold due to a variety of technical, environmental, and community concerns relating to the issues such as right-of-way acquisition, changed circumstances, permitting challenges, and adverse environmental impacts associated with improvements in Rose Canyon; and

WHEREAS, an amendment to the University Community Plan is an amendment to the General Plan because the Community Plan is a component of the General Plan; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the amendments to the General Plan and University City Community Plan Amendment are approved, a copy of which is on file in the office of the City Clerk as Document No. RR- 310814.
