A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THE AUTHORIZATION OF AN APPLICATION FOR ENVIRONMENTAL MITIGATION PROGRAM LAND MANAGEMENT GRANT PROGRAM FUNDS TO THE SAN DIEGO ASSOCIATION OF GOVERNMENTS (SANDAG) AND ALL RELATED ACTIONS FOR HABITAT THREAT REDUCTION AT OTAY MESA SPRING CANYON AND GOAT MESA COMPLEX IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15308.

WHEREAS, the California Environmental Quality Act (CEQA), Public Resources Code section 21084, states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the City of San Diego is considering authorizing the application for \$50,000 in Environmental Mitigation Program Land Management Grant Program funds from the San Diego Association of Governments (SANDAG) and related actions for compliance with the grant and the installation of a minimum of 5,000 feet of three strand wire fence to protect the habitat of endangered and threatened species that exist in the Otay Mesa Open Space areas of Spring Canyon and Goat Mesa (Project); and


WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15308 (Actions by Regulatory Agencies for Protection of the Environment); and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the grant application and the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the authorization of an application for a grant from SANDAG is categorically exempt from CEQA pursuant to CEQA Guidelines section 15308 and that an exception to the exemption does not apply under CEQA Guidelines section 15300.2.
