A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE DISSOLUTION OF THE
LA JOLLA COMMUNITY PARKING DISTRICT.

WHEREAS, Council Policy 100-18 (entitled the “Community Parking District Policy”) provides a mechanism for communities unable to meet existing parking demands to devise and implement parking management solutions to meet their specific needs with the formation of a Community Parking District; and


WHEREAS, pursuant to Resolution R-300586 dated June 27, 2005 and Council Policy 100-18, the City Council approved the formation of the La Jolla Community Parking District and designated Promote La Jolla as its advisory board to implement planning and administration of parking-related activities within the La Jolla community; and

WHEREAS, the La Jolla Community Parking District is currently inactive, and Promote La Jolla is no longer in existence; and

WHEREAS, the La Jolla Community Parking District is no longer necessary as the district does not provide a service in meeting existing parking demands within the district’s boundaries, which are the same as the boundaries of the La Jolla Community Plan area; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the dissolution of the La Jolla Community Parking District is approved.




