DATE OF FINAL PASSAGE DEC 16 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE CITY OF SAN DIEGO'S
ECONOMIC DEVELOPMENT STRATEGY 2017-2019.

WHEREAS, Council Policy 900-01, Economic Development, and the City's General Plan both call for the preparation, consideration, and adoption of a focused Economic Development Strategy every three years; and

WHEREAS, City staff prepared the Economic Development Strategy 2014-2016, relying upon academic studies, existing City land use plans, and Council Policy 900-01, and comprehensive public input from stakeholders such as businesses, business organizations, academia, the military, organized labor, and community groups; and

WHEREAS, the Council adopted Resolution R-309088, effective July 7, 2014, approving the Economic Development Strategy 2014-2016; and


WHEREAS, since July 7, 2014, the Mayor and the Council have approved several strategic documents to serve as the framework for cultivating economic and community development opportunities in San Diego, including the following documents (collectively, City Plans): the 2015-2019 Consolidated Plan, which provides the framework for investment of entitlement programs and funds related to the United States Department of Housing and Urban Development; the 2015 Climate Action Plan, which provides strategies related to conservation, sustainable growth, and resource management in San Diego; and a new Strategic Plan, from which the City's Economic Development Department developed its Tactical Plan; and

WHEREAS, City staff has prepared the Economic Development Strategy 2017-2019 for the Council's consideration, as an update to the previous Economic Development Strategy 2014-2016, to incorporate the City Plans and reflect the City's current priorities and changed realities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council accepts the Economic Development Strategy 2017-2019 and finds that it represents the City's plan for achieving economic growth and fiscal stability for the period of 2017 through 2019.
2. The Council authorizes the Mayor or designee to implement the Economic Development Strategy 2017-2019.




