A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO SELECTING A COUNCIL PRESIDENT.

WHEREAS, San Diego Charter section 270(d) provides that the San Diego City Council (City Council) shall have the right to determine its own rules and order of business, including a process for the selection of a presiding officer to chair City Council meetings and manage the docket process; and

WHEREAS, Rule 4.2 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides that the City Council shall, at the first Council meeting held on or after the tenth day of December, select a President from one of its members by majority vote, to serve for a term of one year or until a successor is selected and qualified, whichever is later; and

WHEREAS, it is now necessary for the City Council to select one of its members to serve as Council President; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that after full discussion and deliberation by the City Council, Councilmember Myrtle Cole is hereby selected as Council President to serve a one-year term commencing on December 12, 2016, and until a successor is selected and qualified.
