A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING FOUR AGREEMENTS WITH
THE CALIFORNIA DEPARTMENT OF TRANSPORTATION
FOR THE MAINTENANCE OF PORTIONS OF STATE
HIGHWAY I-15, STATE HIGHWAY SR-52, STATE
HIGHWAY I-805 AND STATE HIGHWAY SR-125.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council hereby authorizes the Mayor, or his designee to execute, for and on behalf of the City, an agreement with the California Department of Transportation (Caltrans) for the maintenance of portions of State Highway I-15, 11-SD-015 Post Mile 10.0-15.0, under the terms and conditions set forth in Freeway Maintenance Agreement 11-8210 (Clairemont Mesa Blvd to Carroll Canyon Rd.), on file in the Office of the City Clerk as Document No.



That the Council hereby authorizes the Mayor, or his designee to execute, for and on behalf of the City, an agreement with Caltrans for the maintenance of portions of State Highway SR-52, 11-SD-052 Post Mile 4.5-5.25, under the terms and conditions set forth in the Freeway Maintenance Agreement 11-8359 (Convoy St.), on file in the Office of the City Clerk as Document No. RR- 310870-2

3. That the Council hereby authorizes the Mayor, or his designee to execute, for and on behalf of the City, an agreement with Caltrans for the maintenance of portions of State Highway I-805, 11-SD-805 Post Mile 26.5-28.9, under the terms and conditions set forth in Freeway Maintenance Agreement 11-8397 (Carroll Canyon Rd to Sorrento Valley Blvd), on file in the Office of the City Clerk as Document No. RR- 310870-3

4. That the Council hereby authorizes the Mayor, or his designee to execute, for and on behalf of the City, an agreement with Caltrans for the maintenance of portions of State Highway SR-125, 11-SD-125 Post Mile 0.74, under the terms and conditions set forth in Freeway Maintenance Agreement 11-8402 (Otay Mesa Rd), on file in the Office of the City Clerk as Document No. RR- 310870-4

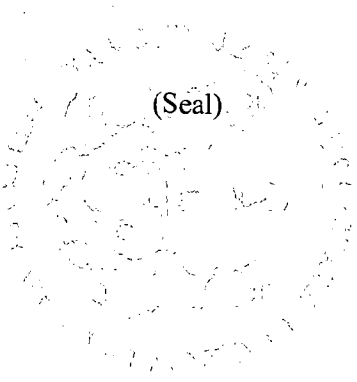
