A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ESTABLISHING NEW COUNCIL POLICY
NO. 200-10 REGARDING HONORARY STREET NAMES.

WHEREAS, the Council of the City of San Diego desires to recognize certain individuals and organizations that are of particular importance to the City of San Diego or have made significant contributions to improving the quality of life in the City by naming sections of public streets in their honor; and

WHEREAS, Ordinance O- 20783, introduced concurrently with this resolution, will amend the Municipal Code to authorize the Council to confer honorary names to public streets and further provides that the criteria and procedure for conferring honorary street names and the design standards for their signage are to be in accordance with Council Policy; and

WHEREAS, the proposed ordinance, if approved, requires establishing a new Council Policy regarding the criteria, procedure and standards for implementation of the honorary naming of streets and signage; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Council Policy No. 200-10 titled "Honorary Street Names" is hereby adopted as set forth in the document on file with the City Clerk as Document No.

RR- 310893, provided that Ordinance No. O- 20783 becomes effective.

2. That the City Clerk is instructed to update the Council Policy Manual by including the new council policy, provided that Ordinance No. O- 20783 becomes effective.


