A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO SELECTING A COUNCIL PRESIDENT PROTEM.

WHEREAS, San Diego Charter (Charter) section 270(d) provides that the San Diego City Council (City Council) shall have the right to determine its own rules and order of business, including a process for the selection of a Council President to chair City Council meetings and manage the docket process, and a President Pro Tem to perform such duties when the President is absent or unable to perform his or her duties; and

WHEREAS, Rule 4.3 of the Permanent Rules of the Council, San Diego Municipal Code section 22.0101 provides that the Council President shall select a President Pro Tem, subject to confirmation by a majority of the City Council; and

WHEREAS, the Council President Pro Tem shall serve for a term of one year and until a successor is selected and qualified, and the position is not subject to term limits; and

WHEREAS, Council President Myrtle Cole has selected Councilmember Mark Kersey to serve as Council President Pro Tem for a one-year term and until a successor is selected and qualified subject to confirmation by the City Council; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that after full discussion and deliberation by the City Council, the City Council confirms the selection of Councilmember Mark Kersey to serve as Council President Pro Tem for a one-year term commencing on December 19, 2016, and until a successor is selected and qualified.
