A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE AUDIT COMMITTEE FOR CALENDAR YEAR 2017.

WHEREAS, San Diego Charter (Charter) section 39.1 establishes an Audit Committee composed of two members of the San Diego City Council (City Council) and three public members; and

WHEREAS, Charter section 39.1 provides that the City Council shall appoint the two Councilmembers, one of whom shall serve as chair of the Audit Committee; and

WHEREAS, because Charter section 39.1 requires a Councilmember to serve as chair of this committee, if the appointed chair is unable to perform his or her duties, the other Councilmember appointee will serve as the acting chair; and

WHEREAS, it is now necessary for the City Council to make the appointments of the two Councilmembers to the Audit Committee for calendar year 2017; and

WHEREAS, under Charter section 280(a)(6), the City Council's appointment of members of the Audit Committee is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Councilmember Georgette Gomez is hereby appointed to the Audit Committee for calendar year 2017 and until a successor is duly appointed and confirmed, and shall serve as the chair of the Audit Committee.

BE IT FURTHER RESOLVED, that Councilmember Scott Sherman is hereby appointed to serve on the Audit Committee as vice chair for calendar year 2017 and until a successor is duly appointed and confirmed.
