AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A SECOND AMENDMENT TO THE AGREEMENT WITH NASLAND ENGINEERING FOR THE OLD OTAY MESA ROAD PROJECT AND EXTENSION OF THE AGREEMENT PAST FIVE YEARS.

WHEREAS, Nasland Engineering is providing design, environmental and other professional engineering services on the City of San Diego's (City) Old Otay Mesa Road project (Project) pursuant to Contract No. H094649, executed June 16, 2010 (Agreement); and

WHEREAS, in response to the community's request for changes to the Project and new regulatory requirements, the Agreement was amended in 2015 to increase the scope of services and extend the contract term; and

WHEREAS, additional services are required to amend the plans and specifications for the Project in order to accommodate construction of a critical 24" water main and the proposed second amendment to the Agreement will increase the scope of services for a compensation amount not to exceed \$127,920 and extend the contract term to September 1, 2021; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a second amendment to the Agreement, under the terms and conditions set forth in the document on file in the Office of the City Clerk as Document No. OO- 20790.

Section 2. That the expenditure of an amount not to exceed \$127,920 (\$84,980 from CIP A-KA.00003, Annual Allocation Large Diameter Water Transmission PPL, B16167, Otay Mesa 680 Zone 24-inch Loop Pipeline, Fund 700010, Water Utility CIP, and \$42,940 from CIP S-00870 Old Otay Mesa Road-Westerly, Fund 400169, Transnet Extension 7) is authorized for the purpose of executing this second amendment to the Agreement, contingent upon the Chief Financial Officer furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
