AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE FIRST AMENDMENT TO THE AGREEMENT WITH ATOS IT SOLUTIONS & SERVICES, INC. FOR DATA CENTER AND HELP DESK IT SERVICES.

WHEREAS, on May 23, 2012, the City Council approved Resolution No. R-307432-1 which authorized the execution of a Master Services Agreement with Atos IT Solutions and Services, Inc. for Data Center and Help Desk Services (Agreement); and

WHEREAS, the parties desire to enter into a First Amendment to the Agreement to extend the term of the Agreement in order to take into account the transition period from the previous vendor and to increase the not to exceed amount and otherwise modify the Agreement pursuant to the terms and conditions of the First Amendment to the Agreement; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of the City, the First Amendment to the Master Services Agreement with Atos IT Solutions & Services, Inc., for the purpose of extending the term of the Agreement through June 30, 2018, increasing the not-to-exceed amount of the Agreement to \$58,475,546, and otherwise modifying the Agreement pursuant to the terms and conditions contained in the First Amendment to the Agreement on file in the Office of the City Clerk as Document No. OO-20811.
