AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING THE CENTRAL VILLAGE SPECIFIC PLAN IN THE OTAY MESA COMMUNITY PLAN AREA – PROJECT NO. 408329.

WHEREAS, the Otay Mesa Community Plan calls for a specific plan for the Central Village Area; and

WHEREAS, on February 23, 2017, the Planning Commission of the City of San Diego considered the Central Village Specific Plan, and voted 5-0-2 to recommend City Council approval of the Central Village Specific Plan; and

WHEREAS, the matter was set for public hearing on April 4, 2017, testimony having been heard, evidence having been submitted and the City Council having full considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That it adopts the Central Village Specific Plan, on file in the Office of the City Clerk as Document No. OO-__20812__.

Section 2. That notwithstanding San Diego Municipal Code section 122.0107, the zoning regulations as specified in the Central Village Specific Plan shall be applicable and where there is a conflict with the base zones set forth in San Diego Municipal Code Chapter 13, the Central Village Specific Plan shall apply.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
