AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 229.2 ACRES LOCATED WITHIN THE OTAY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE AR-1-1 AND OC-1-1 ZONES INTO THE OR-1-2, AR-1-1, RM-2-5, RM-3-7 AND CC-3-6 ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 131.0200, 131.0300, 131.0400 AND 131.0500; AND REPEALING ORDINANCE NO. 0-20362 (NEW SERIES), ADOPTED APRIL 11, 2014, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

WHEREAS, ColRich, Inc., Applicant, requested a rezone for the purposes of changing the zoning on portions of the 229.2 acre Central Village Specific Plan area, located within the Otay Mesa Community Plan, in the City of San Diego, California, from the AR-1-1 and OC-1-1 zones into the OR-1-2, AR-1-1, RM-2-5, RM-3-7 and CC-3-6 zones; and

WHEREAS, on February 23, 2017, the Planning Commission of the City of San Diego considered Rezone No. 1874014 and pursuant to Resolution No. 4842-PC voted 5-0-2 to recommend City Council approval of Rezone No. 1874014; and

WHEREAS, the matter was set for public hearing on April 4, 2017, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 229.2 acres located south of State Route 905, east of Interstate 805, west of Britannia Boulevard and approximately one half mile north of the United States and Mexico International Border, and described by Assessor Parcel Numbers as 6460930500, 6460930700, 6460920600, 6461001800, 6451030900, 6460912200, 6460920500, 6460930900, 6460922100,

This action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. 0-20362 (New Series), adopted April 11, 2014, of the ordinances of the City of San Diego is repealed insofar as the same conflicts with the rezoned uses of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.
