AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO SETTING ASIDE A CERTAIN PORTION OF DEDICATED CITY PARKLAND, COMMONLY KNOWN AS LA JOLLA OPEN SPACE, LOCATED IN THE LA JOLLA COMMUNITY, FOR THE OPENING AND MAINTENANCE OF A CITY STREET PURSUANT TO SAN DIEGO CHARTER SECTION 55.

WHEREAS, the City of San Diego is the owner of 4.50 acres of land in the La Jolla community, commonly known as La Jolla Open Space, which was dedicated for park and recreation purposes on January 9, 1989 (Dedicated Parkland), pursuant to Ordinance No. O-17210 and San Diego Charter Section 55; and

WHEREAS, the Charter provides that, whenever the City Manager recommends it, and the City Council finds that the public interest demands it, the City Council may, without a vote of the people, authorize the opening and maintenance of streets and highways over, through and across City fee-owned land which has heretofore been formally dedicated in perpetuity by ordinance or statute for park, recreation and cemetery purposes; and

WHEREAS, Article XV of the Charter transfers to the elected Mayor all administrative powers, duties and responsibilities previously held by the City Manager; and

WHEREAS, the Mayor now recommends that the public interest demands the opening and maintenance of a street, over, through and across that certain portion of the Dedicated Parkland, in order to complete certain street improvements on the south side of La Jolla Mesa Drive in order to increase driver and pedestrian safety; said street improvements shall include,

but not be limited to, completing a missing section of sidewalk, adding accompanying vehicle turning and travel lanes, as well as a bicycle lane (the La Jolla Mesa Drive Project); and

WHEREAS, that certain portion of the Dedicated Parkland affected by this ordinance is more particularly described in the document entitled "Streets and Highways Use on Dedicated Parkland," comprised of a legal description and Engineer's Drawings Nos. 39812-1-B and 39812-2-B, a copy of which is on file in the Office of the City Clerk as Document No.

20816; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council hereby finds that the public interest demands the opening and maintenance of a street, over, through and across that certain portion of the Dedicated Parkland, in order to complete the La Jolla Mesa Drive Project; that certain portion of the Dedicated Parkland is more particularly described in the document entitled "Streets and Highways Use on Dedicated Parkland," comprised of a legal description and Engineer's Drawings Nos. 39812-1-B and 39812-2-B, a copy of which is on file in the Office of the City Clerk as Document No. OO-
