AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AGREEMENT WITH URS CORPORATION FOR ENVIRONMENTAL AND PERMITTING CONSULTANT SERVICES RELATED TO EXTENDING THE LIFE OF THE MIRAMAR LANDFILL.

WHEREAS, on September 25, 2012, the City of San Diego (City) entered into an agreement with URS Corporation in the amount of \$249,000 for environmental and permitting consultant services related to extending the life of the Miramar Landfill (Agreement); and

WHEREAS, the City encountered unforeseen delays due to regulatory coordination with the Federal Aviation Administration (FAA) and environmental document preparation for a project to extend the life of the Miramar Landfill, which delayed completion of the Scope of Services and depleted the amount of available funding under the Agreement; and

WHEREAS, this First Amendment to the Agreement will add funding in an amount not to exceed \$103,000 (for a total contract amount of \$352,000) and will extend the Agreement term through November 14, 2021, for the purpose of completing the Scope of Services; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

(O-2017-134)

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of

the City, a First Amendment to the Agreement with URS Corporation for environmental and

permitting consultant services related to extending the life of the Miramar Landfill, to add funding

in an amount not to exceed \$103,000 and to extend the term of the Agreement through November

14, 2021, for the purpose of completing the Scope of Services, under the terms and conditions set

forth in the First Amendment to the Agreement, on file in the Office of the City Clerk as

Document No. OO- 20832

Section 2. That the Chief Financial Officer is authorized to expend an amount not to

exceed \$103,000 from Refuse Disposal Fund No. 700039, solely and exclusively to provide

funds for the First Amendment to the Agreement, contingent upon the Chief Financial Officer

furnishing one or more certificates demonstrating that funds are, or will be, on deposit with the

City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a

written copy having been made available to Council and the public prior to the day of its

passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
