ORDINANCE NUMBER O- 20840 (NEW SERIES)

DATE OF FINAL PASSAGE JUN 30 2017

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SECOND AMENDMENT TO THE CONSULTANT AGREEMENT WITH MICHAEL BAKER INTERNATIONAL FOR THE EL CAMINO REAL HALF-MILE TO VIA DE LA VALLE PROJECT.

WHEREAS, Michael Baker International (formerly RBF Consulting) entered into a consultant agreement with the City of San Diego to provide environmental review services for the El Camino Real Half-Mile to Via de La Valle Project (Project) on April 20, 2011, as Document No. RR-306817; and

WHEREAS, the original agreement with RBF Consulting was required in order to complete the Environmental Assessment in accordance with the National Environmental Policy Act; and

WHEREAS, the Second Amendment to the agreement with Michael Baker International (formerly RBF Consulting) is for a time extension only with no cost increase to the Consultant Agreement with Michael Baker International to complete the environmental studies and resource agency permits;

WHEREAS, the Second Amendment to the Agreement with Michael Baker International (formerly RBF Consulting) will extend the total term of the Agreement to December 31, 2020; and;

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE;


BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the Second Amendment to the Consultant Agreement with Michael Baker International, on file in the office of the City Clerk as Document No. OO- ~~20840~~ for environmental services in CIP S-00856, El Camino Real – Half Mile to Via de la Valle.

Section 2. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been made available to the City Council and the public a day prior to its final passage.

Section 3. That this ordinance shall take effect, and be in force on the thirtieth day from and after its final passage.
