DATE OF FINAL PASSAGE JUL 25 2017

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING ONE COUNCIL COMMITTEE CONSULTANT FROM THE CLASSIFIED SERVICE.

WHEREAS, on May 19, 2017, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Council President to exempt one Council Committee Consultant position from the Classified Service; and

WHEREAS, this position will support a new Council Committee – the Select Committee on Homelessness; and

WHEREAS, the Committee Consultant will work in Council Administration and report to the Chair of the Select Committee on Homelessness; and

WHEREAS, the position will analyze and evaluate homeless issues in the City of San Diego, including current and new homeless programs, funding mechanisms, and City department efforts to address homelessness; and

WHEREAS, the position will also make recommendations to and advise the Council Committee and update the City's comprehensive Homeless Council Policy; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on May 19, 2017, upon review of the duties and responsibilities of the Council Committee Consultant position, as provided by the Council President, the Civil Service Commission determined that the Council Committee Consultant position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determination of the Civil Service Commission is set forth in a memorandum dated May 25, 2017, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated May 25, 2017, which documents that, on May 19, 2017, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Council President to exempt one Council Committee Consultant position from the Classified Service, to work in Council Administration and support the Select Committee on Homelessness.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the City Council exempts from the Classified Service and declares to be in the Unclassified Service of the City one Council Committee Consultant position, performing the duties set forth in the May 25, 2017 memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the City Council and the public prior to the day of its passage.

Section 4.	That this ordinance shall take effect and be in force	on the thirtieth day
