AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENTS TO THE CITY'S CLASS I AND CLASS II NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE AGREEMENTS.

WHEREAS, by ordinance, the City Council granted solid waste collection franchises to, and authorized execution of franchise agreements with, the Class I and Class II franchisees listed on the attached Exhibit A; and

WHEREAS, the proposed amendments provide for a seven-year term with an option for annual, one-year extensions, subject to City Council approval by ordinance, and amend franchisee container signage requirements, under the terms and conditions set forth in the proposed franchise amendments; and

WHEREAS, City staff have met with the franchisees regarding the proposed franchise amendments; and

WHEREAS, on May 25, 2017, the Environment Committee unanimously recommended approval of this item; and

WHEREAS, under Charter section 103, no franchise or extension thereof may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, Ninth Amendments to the Class I Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class I franchisees listed on the attached Exhibit A, under

the terms and conditions set forth in the Ninth Amendment on file in the Office of the City Clerk as Document No. OO- 20843.

Section 2. That the Mayor or his designee is authorized to execute, for and on behalf of the City, Eighth Amendments to the Class II Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class II franchisees listed on the attached Exhibit A, (except for EDCO Disposal Corporation dba Daily Disposal Services, Inc.), under the terms and conditions set forth in the Eighth Amendment on file in the Office of the City Clerk as Document No. OO- 20843.2

Section 3. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a Seventh Amendment to the Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services with EDCO Disposal Corporation dba Daily Disposal Services, Inc., under the terms and conditions set forth in the Seventh Amendment on file in the Office of the City Clerk as Document No. OO- 20843.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.
