AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE THIRD AMENDMENT TO THE CONSULTANT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND KLEINFELDER (FORMERLY SIMON WONG ENGINEERING, INC.).

WHEREAS, Kleinfelder (formerly Simon Wong Engineering, Inc.) entered into a consultant agreement with the City of San Diego to provide professional engineering services for the Replacement of the Georgia Street Bridge Over University Avenue Phase 1 (Project) on November 18, 2008, as Document No. RR-304379; and

WHEREAS, the First Amendment to the consultant agreement, entered into on November 9, 2011 as Document No. RR-307084, allowed for the completion of the requested Rehabilitation Report, additional field investigations, engineering coordination and preliminary engineering for the selected alternatives for the required environmental documents; and

WHEREAS, the Second Amendment to the consultant agreement, entered into on October 8, 2013 as Document No. RR-309525, allowed for the completion of the plans, specifications, and estimate and provided for limited construction support for the selected alternative; and

WHEREAS, the Third Amendment will provide additional time and budget for construction support services for the remainder of construction of the Georgia Street Bridge; NOW, THEREFORE;

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the Third Amendment to the Agreement with Kleinfelder (formerly Simon Wong Engineering, Inc.) for engineering services for CIP S-00863, Georgia Street Bridge Improvements in the amount not to exceed \$100,000.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$100,000 from CIP S-00863, Georgia Street Bridge Improvements, Fund 600000, Grant Fund – Federal, Grant No. 1000502-2017 Georgia Street Bridge, for the purpose of executing the Third Amendment to the Consultant Agreement with Kleinfelder.

Section 3. The Mayor or his representative is authorized to make applications to Caltrans and take all necessary actions to secure funding in an amount not to exceed \$300,000 in Fund 600000, Grant Fund – Federal, for the Georgia Street Bridge Improvements.

Section 4. The Chief Financial Officer is authorized to increase the Fiscal Year 2017 Capital Improvements Program Budget in CIP S-00863, Georgia Street Bridge Improvements, and to accept, appropriate and expend an amount not to exceed \$300,000, Fund 600000, Grant Fund – Federal, for the purpose of construction, contingent upon receipt of a fully executed grant agreement if the grant funding is secured.

Section 5. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been made available to the City Council and the public a day prior to its final passage.

Section 6. That this ordinance shall take effect, and be in force on the thirtieth day from and after its final passage.
